a. Central Complex

1. Deadline for sealed bids was September 21, 2021 by 2 pm. Four bids received by the Bossier Parish Police Jury and no online bids were received. It was stated before bids were opened that the designers' estimate was \$9,750,000. The four sealed bids received were opened and read aloud at 2 pm. Bids are as follows:

D. Financial Report

a. July and August 2021 Operating and Construction Funds

As of July 31, 2021, the Operating Fund revenue was \$7,578,756 and expenditures were \$6,362,096. It was noted that the expenditures include \$2 million transferred at the beginning of 2021 to the Construction Fund. The ending fund balance was \$6,927,702.

As of July 31, 2021, the Construction Fund revenue was \$2,011,653 and expenditures were \$268,378. The ending fund balance was \$9,953,680.

As of August 31, 2021, the Operating Fund revenue was \$7,587,960 and expenditures were \$6,876,704. The ending fund balance was \$6,483,735.

As of August 31, 2021, the Construction Fund revenue was \$2,012,827 and expenditures were \$273,378. The ending fund balance was \$9,949,854.

Motion made by Mr. Gray, seconded by Mrs. Gore, to accept the July and August 2021 Operating Fund and Construction Fund reports. Motion carried unanimously.

b. 2022 Proposed Budgets

The board was presented with the 2022 Proposed Operating and Construction Budgets for review.

Motion to approve the 2022 Operating Budget as presented was made by Mr. Gray, seconded by Mrs. Gore. Motion carried unanimously.

Motion to approve the transfer of \$2 million from the ending net assets in the operating budget to the construction fund and to approve the 2022 Construction Budget as presented was made by Mr. Gray, seconded by Mr. Brotherton. With the additional \$2 million, the total beginning budget for 2022 will be an estimated \$11,949,854. Motion carried unanimously.

E. Director's Report

a. Summer Experience Statistics

The library had a successful program with participation and completion rates, from the youngest readers, to teens and adults.

V. Adjourn

There being no further business, Mrs. Gore motioned to adjourn, seconded by Mr. Gray. Motion carried unanimously. The meeting adjourned at 1:19 pm.
